Dear Resident:

Thank you for your interest in serving on Corinth City Council. If you decide to become a candidate, your candidacy must comply with certain state statutes and local ordinances. Corinth operates under state law and its own Charter. Please realize the material in this packet is not exhaustive and that it is the responsibility of a candidate/officeholder to become familiar with and follow all laws, rules, and regulations applicable to municipal campaigns.

There are two places on the City Council for the May 2, 2026, General Election:

Mayor  
Council Member – Place 5

Candidates filing for office must meet the qualifications as outlined in the City of Corinth Home Rule Charter, Section 3.01, and Chapter 141 of the Texas Election Code: <https://statutes.capitol.texas.gov/?link=EL>. The City Secretary's Office is responsible for the oversight of the election process and is limited to accepting and filing applications, affidavits, and statements, noting the date and time for filing. The City Secretary is not permitted to advise candidates of their responsibilities or to judge or comment upon the timeliness or sufficiency of reports filed.

Upon filing an application for a place on the ballot, the City Secretary must review the application to determine whether it complies with the requirements of the Texas Election Code, Section 141.032, as to form, content, and procedure only. The City Secretary verifies that the document was filed correctly and in a timely manner and that all required information is completed and attested to by the applicant. The review must be completed not later than the fifth day after the date the application is received by the authority. If an application does not comply with applicable requirements, the City Secretary must reject the application and provide the candidate with written notice of the rejection. [EC Sec. 141.032(e)]. Candidates should review materials fully before submitting the application. Corrections are not permitted once submitted.

Please file your application as soon as practicable to allow sufficient time for application review. Filing at the last minute may not allow the City Secretary's Office sufficient time for review, which is subject to state law, not City preference. Please do not leave any required information blank on the application, as doing so may render your application invalid.

All applications, affidavits, statements, and campaign reports filed with the City Secretary's Office are considered public information and are open to inspection by the public in accordance with the Texas Public Information Act.

The filing period for a place on the ballot is January 14 – February 13, 2026, 5:00 P.M.

### Drawing for Place on the Ballot

In the event more than one applicant applies for the same place on the ballot, a drawing will be conducted by the City Secretary's Office to determine the order in which the candidates' names appear on the ballot. The drawing will be held **Friday, February 19, 2026, at 4:45 pm, at City Hall, 3300 Corinth Parkway, Suite 210**. Candidates or their representatives are encouraged to attend, but attendance is not required. If a candidate is not present, the City Secretary or designee will draw for them.

### Election Canvass

The election results will be canvassed on **Tuesday, May 12, 2026**.

## Campaign Finance Reports

All Campaign Finance Reports are filed locally with the City Secretary. Candidates and officeholders do not file reports with the Texas Ethics Commission. The City Secretary is not required to send a candidate or officeholder a notice to file; has no responsibility for making sure that candidates, officeholders, or political committees file the required documents; nor has the authority to penalize a filer for failure to submit a required filing. However, filers should be aware that there are penalties for violating the Campaign Finance Law, and the forms are open to the public and the media upon request. The City Secretary is not obligated to answer Campaign Finance Law questions or ensure the forms' accuracy.

Council Candidates are considered "local filers," and therefore, all forms should be filed with the City Secretary. No forms are required to be filed with the Texas Ethics Commission or Secretary of State. However, some forms may be available at the source website to fill in the form electronically and print for submittal.
